# FUTURE OF MID-ATLANTIC RACING

DR. CORINNE SWEENEY: HOPES FOR THE

crisp autumn afternoon brightened the grounds of the New Bolton Center in Kennett Square, Pa. The vibrant colors filtered through the large window of Dr. Corinne Sweeney's office, only to be rivaled by her warm, welcoming smile. Behind a paper-strewn desk, Sweeney balances life as a professor of medicine and associate dean for New Bolton Center, but she always manages to find a new enthusiasm each day.

Sweeney grew up in Monkton, Md., a wellknown equine community that helped foster an interest in horses at a young age. "I was in pony club and my parents took us to see the races at Timonium," she says. "We went to point-to-point races and everything just continued from there."

Following her passion for horses, Sweeney decided to focus on veterinary medicine and developed a specialty in equine respiratory diseases. Shortly after, she took an internship at New Bolton and found that she had no desire to turn back. By Brooke Ketron



In addition to her duties at New Bolton, Sweeney also holds the title as chairman of the Pennsylvania State Horse Racing Commission, a position she was appointed to by Governor Ed Rendell in 2005.

"I didn't grow up in a racing family," Sweeney admits,

"but I was always around racing. I just love working with everybody involved in the industry. I enjoy having a role in helping the industry prosper."

During a time when live racing faces a great amount of competition, Sweeney finds the addition of slots to racetracks to be beneficial. "Slots have made a tremendous difference to racing, particularly in Breeder Awards and larger purses," Sweeney states confidently. "It shows that Pennsylvania is committed to both live racing and the breeding industry, which means better horses and better races."

Parx Racing recently made history Sept. 22 when it featured two races worth \$1 million on the same card. "The only other time that is done in the United States is the Breeders' Cup," says Sweeney. "It's been great promotion for Pennsylvania racing, which can benefit all of our neighboring states. After all, a rising tide lifts all boats."

A band of Pennsylvania-breds made an impressive rally at the Maryland Million races in October at Laurel Park. Sweeney credits the addition of slots in helping the Pennsylvania breeding program blossom, noting the state's division of the Northview Stallion Station as an indicator of the prospering breeding program.

"I'm so proud of the increased support of Pennsylvania-bred horses and racing, especially from track managements and all the horsemen," Sweeney adds.

However, her time on the racing commission has not been without a few struggles. Racing competes with all other major sporting events, many which cost a lot more to attend. It can seem bizarre that racetracks can become a bit barren when compared to packed football stadiums during the fall. The downfall may come in the promotion, or lack thereof, for local racetracks.

"It can be challenging to remember that racing needs to be promoted just as much as any other sport," Sweeney says. "The entire industry is a partnership and we must work together to publicize racing as much as we do the casino end of the track."

Sweeney intends to use her roles to facilitate an environment that encourages growth and camaraderie within the equine industry. To her, the continued support of racing lies within the power of all in the industry to take initiative to bring in the next generation of horsemen and fans to the track.

"Racing receives a lot of public scrutiny," Sweeney says, "but if people will come to the tracks-racing will certainly sell itself. There is nothing else like live racing."

Despite the challenges at hand for the industry, Sweeney remains optimistic. After all, she is faced with many difficult situations every day at New Bolton. "Difficult doesn't mean it can't be done," she says, her hopes for racing outshining the autumn view just beyond her window.

### **OVERVIEW OF AWARDS AND BONUSES FOR REGISTERED PA-BREDS**

- \$ Award of 30% of purse earned to Breeder for PA-sired horses (first through third)
- \$ Award of 20% of purse earned to Breeder for non PA-sired horses (first through third)
- \$ Award of 10% of purse earned to Stallion Owner (first through third)
- \$ Award of 10% of purse earned to winning Owner on selected open races
- \$ Bonus of up to 40% of purse earned to Owner on selected races (first through third)
- \$ Bonus of 25% of purse earned to Owner for PA-sired horses in PA-Bred stakes races (first through third)

Pennsylvania Breeding Fund has grown from a disbursement of \$65,000 in its initial year of operation to over \$15 million annually.

The Pennsylvania Breeding Fund is financed by a percentage of pari-mutuel handle and slots revenues. It provides for individual award payments (breeder, owner and stallion awards), overnight races for PA-Breds, purse bonus supplements, and PA-Bred stakes races.
