—PHBA'S FOCUS ON—

HORSE RACING & THE YOUTH: SECURING THE FUTURE – PART I

Churchill Downs 50 years from now. The Twin Spires with a bright, blue sky in the background. The first Saturday in May. Horses churn the track, but the stands are empty. Betting lines dwindle and ticket sales for the Kentucky Derby are at an all time low. Not far away, the stands are packed for a Major League Baseball game. People of all ages gather to tailgate, socialize and enjoy a beloved American pastime, without a second thought that it is Derby Day.

Not too long ago, horse racing was the premiere sport and pastime of Americans. Businesses closed their doors to hear the call of the historic Seabiscuit and War Admiral match race of 1938. Families gathered around the radio, each cheering for a personal favorite in the Kentucky Derby and the most coveted spot at the racetrack was anywhere one caught a glimpse of the horses flashing by.

Horse racing brought all ages and social groups together. Most people lucky enough to live during the last Triple Crown winners remember where they were when Secretariat demolished the Belmont Stakes field. Chick Anderson's call of the 1973 race still brings chills.

Yet in recent years, horse racing began battling negative press and stigmas. The enthusiastic and diverse crowds of race-goers became specific to major events like the Triple Crown races or the Breeders' Cup. Now men, with gray hair and foggy memories, compose the majority of track specta-

tors, sparsely occupying the grandstand and obtaining any vantage point.

The youth have virtually disappeared from the tracks, making the future of horse racing uncertain.

"Without new fans to replace the old, there will be no racing industry," comments David May, CEO of Thorostat.com, a horse racing handicapping site he recently started. Like many, May's father exposed him to horse racing at a young age, and he credits that early education for fostering his interest in the sport.

Stephen Whyno, sports reporter at The Washington Times, also credits his upbringing for encouraging his interest in the sport. "If not for my family history, I don't know if I ever would have grown up with horse racing. There are so many other options available that are easier to see," he notes.

Between other major professional sports and the addition of casinos to many race-tracks, the young adults are provided with many forms of entertainment and professional outlets, many of which are marketed specifically for the 18 to 30-year-old demographic. "Racing is just not mainstream anymore," says Whyno.

Not only does a lack of focused marketing fail to attract the young masses to racing and create new fans, but the absence of accessibility to equine professionals also poses a problem.

In a time where young people are drawn to brand names and major corporations, it becomes difficult for equine athletes to compete with their human counterparts.

Racehorses reach their twilight years quicker than professional athletes, meaning they have fewer, and often fleeting, opportunities to obtain and build a dedicated following. Horses like Union Rags and Smarty Jones garnered positive media attention for the racing industry, but their early retirements made it hard to keep the fans' attention.

Instead, young people flock to major athletes like Robert Griffin III—who revived the football market in Washington, D.C., in his rookie year. His regular and personal interaction with fans is a rewarding aspect of major sports that retains the young market's interest.

"There seems to be a wall in place which prevents younger people from meeting and knowing more about the equine athletes," says Melissa Nolan, Marketing Director for the Kentucky Thoroughbred Association.

The restricted access to racing stars, whether by track security protocols or

the breeding farms, makes it difficult to keep their names current among fans and media. In turn, this leaves fans searching for the next best thing, whether it is an active racehorse or another sport entirely.

Racetracks also compete with the casinos they affiliate with, making the business seem like a double-edged sword. Casinos bring in millions of dollars to benefit racing purses, breeder awards and incentives, but the bright lights and flashy advertisements draw the youth there instead of the track.

"Casinos tend to get 10 times more exposure then any track they are associated with," comments May, "many young people play the lottery, poker and casino games, but don't play the ponies. I think the industry needs to do a better job of promoting races and show fans that it is alright to go to the track."

The 2012 Kentucky Derby set a new record for attendance with 165,307 people filling the stands. The Preakness Stakes also increased handle and

attendance since infield policy changes in 2007, proving that there is a national interest in racing. Yet, it requires a focused marketing effort that lasts beyond major events.

"Important entities in the business are making efforts that should ensure increased power and participation of a more youthful constituency within the thoroughbred industry for years to come," expresses Nolan.

With time comes change and for the security of the sport the industry must adapt and evolve to the young market to ensure its survival. The road ahead may be difficult, but with the help and devotion of fans, professionals and institutions, solutions can be found to return horse racing to a prominent sport full of promise, growth and passion.

Pennsylvania's Breeding Fund Program distributes more money, on a per foal basis,

than nearly every other state-bred program now in operation. Established in 1974, the Pennsylvania Breeding Fund has grown from a disbursement of \$65,000 in its initial year of operation to over \$15 million annually.

OVERVIEW OF AWARDS AND BONUSES FOR REGISTERED PA-BREDS

- \$ Award of 30% of purse earned to Breeder for PA-sired horses (first through third)
- \$ Award of 20% of purse earned to Breeder for non PA-sired horses (first through third)
- **\$** Award of 10% of purse earned to Stallion Owner (first through third)
- \$ Award of 10% of purse earned to winning Owner on selected open races
- \$ Bonus of up to 40% of purse earned to Owner on selected races (first through third)
- \$ Bonus of 25% of purse earned to Owner for PA-sired horses in PA-Bred stakes races (first through third)
