

# 2018 PA BROODMARE DOMICILE REPORT – FOR MARES FOALING IN 2018

**FOAL REGISTRATION CRITERIA** - A Thoroughbred foal born in the state of Pennsylvania in **2018** and registered as such with The Jockey Club is eligible for Pennsylvania-Bred registration with the Pennsylvania Horse Breeders Association if one of the following conditions is met:

Check one box below for which the foal of the subject broodmare will qualify.

- (1) The dam of the foal resided **continuously** in Pennsylvania **on or before December 1, 2017, through foaling**. Mares not being bred back will fall under this category; or
- (2) The dam of the foal was purchased at a **public sale after December 1, 2017**, then brought into Pennsylvania **within 14 days of the date of purchase, and resided in Pennsylvania through foaling**. During the year of foaling (**2018**), the foal or its dam must spend at least 90 days in the state; or
- (3) **The dam of the foal will be bred back in 2018** to a stallion standing in Pennsylvania (which is registered with the Pennsylvania Horse Breeders Association as a Pennsylvania stallion during the breeding season of the year of foaling) and **reside in the state for at least sixty (60) consecutive days during which foaling occurred**.
